## Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

## How we use your information

#### Where we store your information

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

Certain employees within our organisation and our contractors may receive your data via email where you have completed our website contact form or carried out a transaction on our site. The data will only be used for the purpose of completing your transaction or to respond to you about your communication with us. Those allocated individuals accessing your data have a duty of confidentiality.

#### Log Files

Guided Financial Strategies follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analysing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

#### Cookies and Web Beacons
